PROCLAMATION NO. 1217

CREATING AND DESIGNATING A BUILDING LOCATED ALONG QUEZON AVENUE CORNER ROOSEVELT AVENUE, BARANGAY STA. CRUZ, QUEZON CITY, AS AN INFORMATION TECHNOLOGY CENTER, PURSUANT TO REPUBLIC ACT NO. 7916, AS AMENDED BY REPUBLIC ACT NO. 8748

Pursuant to the powers vested in me under Republic Act (RA) No. 7916, otherwise known as the "Special Economic Zone Act of 1995," as amended by RA No. 8748, and upon the recommendation of the Board of Directors of the Philippine Economic Zone Authority (PEZA), I, BENIGNO S. AQUINO III, President of the Philippines, do hereby create and designate a building, subject to the provisions of RA No. 7916, as amended, its Implementing Rules and Regulations, Resolution No. 00-411 (s. 2000), as amended by Resolution Nos. 11-066 (s. 2011) and 15-240 (s. 2015), and Resolution No. 15-089 (S. 2015) of the PEZA Board of Directors, as an Information Technology (IT) Center, to be known as the Fishermall, with a gross floor area of One Hundred Four Thousand Five Hundred Thirty-Eight square meters and Seventy-One square (104,538.71), which stands on several parcels of land, located along Quezon Avenue corner Roosevelt Avenue, Barangay Sta. Cruz, Quezon City, with an aggregate area of Eighteen Thousand Three Hundred Forty-Six square meters and Thirty square decimeters (18,346.30), more or less, as defined by the following technical description:

Lot 1, Block W-26 Bsd-7165-D TCT No. 004-2011009485

A parcel of land (Lot 1, Block W-26 of the subdivision plan, Bsd-7165-D, being a portion of Lot R.P. 3-B-2-B, Bsd-7365-C, LRC [GLRO] Rec. No. 7681), situated in the District of Diliman, Quezon City.

Bounded on the SE., along line 1-2 by Lot R.P. 3-B-2-B, Bsd-7365-C (Quezon Boulevard); on the SW., along lines 2-3-4 by R-282 of the subdivision plan; on the NE., along line 8-1 by Lot 2, Block W-26 all of the subdivision plan.
