PROCLAMATION NO. 843

DESIGNATING SEVERAL PARCELS OF LAND LOCATED IN BARANGAYS SAN FERNANDO, LUTA NORTE AND LUTA SUR, MALVAR, BATANGAS, FOR INCLUSION IN THE EXISTING LIGHT INDUSTRY & SCIENCE PARK IV SPECIAL ECONOMIC ZONE, PURSUANT TO REPUBLIC ACT NO. 7916, AS AMENDED BY REPUBLIC ACT NO. 8748

Pursuant to the powers vested in me under Republic Act (RA) No. 7916, or the "Special Economic Zone Act of 1995," as amended by RA No. 8748, and upon the recommendation of the Board of Directors of the Philippine Economic Zone Authority (PEZA), **I**, **RODRIGO ROA DUTERTE**, President of the Republic of the Philippines, do hereby designate several parcels of land with an aggregate area of **Four Hundred Seventy-Two Thousand Four Hundred Nine square meters (472,409 m²)**, more or less, located in Barangays San Fernando, Luta Norte and Luta Sur, Malvar, Batangas, for inclusion in the existing **Light Industry & Science Park IV Special Economic Zone**, subject to the provisions of RA No. 7916, as amended, its Implementing Rules and Regulations, PEZA Board of Directors Resolution No. 13-743 (s. 2013), as amended by Resolution No. 15-314 (s. 2015) and Resolution No. 18-658 (s. 2018), as defined by the following technical description:
