
Sirs/Mesdames:

Please take notice that the Court, First Division, issued a Resolution dated September 15, 2014 which reads as follows:

“A.M. No. P-14-3229 [formerly OCA IPI No. 12-3958-P] (Corazon M. Mancenido v. Evangeline R. Mendoza, Court Legal Researcher III, Regional Trial Court, Branch 49, Manila). - The Court **RESOLVES** to **ADOPT** and **APPROVE** the findings of fact and conclusions of law of the Office of the Court Administrator in its Memorandum¹ dated March 14, 2014 with **MODIFICATION** as to the recommended penalty. Accordingly, the Court finds respondent Evangeline R. Mendoza **GUILTY** of Simple Dishonesty and is meted with the penalty of **SUSPENSION** for a period of two (2) months with a **STERN WARNING** that a repetition of the same or similar offense will be penalized more severely.
