

Please take notice that the Court, Second Division, issued a Resolution dated **13 October 2014** which reads as follows:

G.R. No. 209337: PEOPLE OF THE PHILIPPINES v. ROMEO ORDOÑEZ Y CASTRO

The Court of Appeals elevated the records of this case to this court on October 22, 2013 pursuant to its resolution dated May 27, 2013.¹ The resolution gave due course to the notice of appeal filed by accused-appellant Romeo Ordoñez.

In a resolution² dated December 4, 2013, this court noted the records forwarded by the Court of Appeals and informed the parties that they may file their supplemental briefs.

On February 7, 2014, accused-appellant³ and the Office of the Solicitor General⁴ filed separate manifestations that they would no longer file supplemental briefs as they had already stated their arguments in their respective briefs before the Court of Appeals.

After an evaluation of the records of the case, this court resolves to **DISMISS** the appeal of accused-appellant Romeo Ordoñez for failure to sufficiently show reversible error in the challenged decision warranting the exercise of this court's appellate jurisdiction.

WHEREFORE, the decision dated April 30, 2013 of the Court of Appeals in CA-G.R. CR-H.C. No. 05453 is hereby **AFFIRMED in toto**.
