

Sirs/Mesdames:

*Please take notice that the Court, Second Division, issued a Resolution dated **15 September 2014** which reads as follows:*

G.R. No. 211865 (ERLINDA BAYLON MAHILOM v. RHINE MARKETING CORPORATION and ESMERALDA DAVID. - In our June 2, 2014 resolution, we denied petitioner Erlinda Baylon Mahilom's Rule 45 petition for review on *certiorari* for failure to show any reversible error sufficient to warrant the exercise of the Court's discretionary appellate jurisdiction.

In this motion for reconsideration, the petitioner **re-submits that she did not resign from her employment.** She claims that the subject resignation letter should not be given evidentiary weight since the letter was written in the form of the company's wordings whose tenor could not be written by someone who is only a high school graduate. She also asserts that in line with settled jurisprudence, the controversy should be resolved in her favor.

We find the motion for reconsideration **unmeritorious.** It raises no new arguments. The petitioner's argument (that she did not resign from work) is **merely a reiteration** of those already found, considered and ruled upon in the Resolution denying her Rule 45 petition. Hence, we deny the motion for lack of merit.

WHEREFORE, premises considered, we **DENY** the present motion for reconsideration with finality.
