

Please take notice that the Court, Second Division, issued a Resolution dated **10 December 2014** which reads as follows:

**G.R. No. 215538: ANGELITO S. PACULOB v. MAERSK-FILIPINAS CREWING, INC., ET AL.**

Pursuant to Rule 141, Section 19 of the Rules of Court, this court resolves to **GRANT** petitioner's motion to declare him as indigent or pauper-litigant.<sup>1</sup>

After considering the allegations, issues, and arguments adduced in the petition for review on certiorari assailing the Court of Appeals decision<sup>2</sup> dated March 31, 2014 and resolution dated August 26, 2014, this court resolves to **DENY** the petition for failure to show any reversible error in the assailed decision and resolution and for raising substantially factual issues. We **AFFIRM** the Court of Appeals decision denying petitioner's petition for certiorari and upholding the National Labor Relations Commission decision dated September 30, 2011.

However, in view of this court's ruling in *Nacar v. Gallery Frames*,<sup>3</sup> the assailed decision is **MODIFIED** as to the rate of legal interest.

**WHEREFORE**, the assailed decision is **AFFIRMED with MODIFICATION** in that the monetary award shall earn interest at the rate of 6% per annum from the date of finality of the judgment until fully paid. (*Brion, J. on leave; Villarama, Jr. J., designated acting member per S.O. No. 1888 dated November 28, 2014.*)
