


*Please take notice that the Court, First Division, issued a Resolution dated **January 12, 2015** which reads as follows:*

“A.C. No. 9029 [formerly CBD Case No. 12-3404] (Sharon Flores-Concepcion v. Atty. Arnaldo P. Dizon and Provincial Prosecutor Aladin C. Bermudez, Jr.)- The petition for review dated September 30, 2014 (with enclosures) of respondent Provincial Prosecutor Aladin Bermudez, Jr., praying that the instant disbarment complaint be dismissed for lack of evidence is **NOTED**.

The Court **RESOLVES** to **ADOPT** and **APPROVE** the findings of fact, conclusions of law, and recommendation of the Integrated Bar of the Philippines in the attached Resolution¹ dated June 22, 2013. Accordingly, the Court finds respondents Atty. Arnaldo P. Dizon and Provincial Prosecutor Aladin C. Bermudez, Jr. **GUILTY** of violating Canon 7 and Canon 10, Rules 10.1 and 10.2 of the Code of Professional Responsibility and are thus meted with the penalty of **SUSPENSION** from the practice of law for a period of six (6) months, with a **STERN WARNING** that a repetition of the same shall be dealt with more severely.²
