

Please take notice that the Court, First Division, issued a Resolution dated February 16, 2015 which reads as follows:

“G.R. No. 180484 (Renboc International Corporation/Renbexx Incorporated and/or Nestor Bocaya/Renato Bocaya v. Shalemar H. Buenaventura).

G.R. No. 180811 (Shalemar H. Buenaventura v. Renboc International Corporation/Renbexx Incorporated and/or Nestor Bocaya/Renato Bocaya). -

After a judicious review of the records, the Court resolves to **DENY** the petition in G.R. No. 180811 and **AFFIRM** the August 6, 2007 Decision¹ and November 12, 2007 Resolution² of the Court of Appeals (CA) in CA-G.R. SP No. 96574 for failure to sufficiently show that the CA committed any reversible error in denying the Motion for Extension of Time to file Motion for Partial Reconsideration filed by petitioner Shalemar H. Buenaventura (Buenaventura) which, thus, rendered the CA rulings final, executory, and unalterable as to him.

As correctly ruled by the CA, Buenaventura’s Motion for Extension of Time to file Motion for Partial Reconsideration did not toll the running of the period for the finality of its August 6, 2007 Decision. Verily,





Buenaventura failed to timely file a motion for partial reconsideration. As such, the CA rulings had achieved finality due to the lapse of the reglementary period. Accordingly, Buenaventura's subsequent motion for partial reconsideration of the CA's August 6, 2007 Decision was properly denied admission.
