

Please take notice that the Court, Second Division, issued a Resolution dated **22 June 2015** which reads as follows:

G.R. No. 202207 – *People of the Philippines, plaintiff-appellee v. Nelly Collamar, accused-appellant.*


After a careful review of the records of the case, the Court finds the appeal to be lacking in merit. We adopt the findings of facts of the trial court as affirmed by the Court of Appeals. Both the Regional Trial Court of Pasig City, Branch 167 and the Court of Appeals correctly found appellant Nelly Collamar guilty beyond reasonable doubt of the crime of qualified theft. She was also properly sentenced to suffer the penalty of *reclusion perpetua* and to indemnify the offended party the amount of ₱801,051.75. Moreover, appellant is without eligibility for parole.

WHEREFORE, we **ADOPT** the findings of facts of the trial court as affirmed by the Court of Appeals. The assailed January 30, 2012 Decision of the Court of Appeals in CA-GR. CR.-H.C. No. 04459 finding appellant Nelly Collamar guilty beyond reasonable doubt of the crime of qualified theft in Crim. Case No. 132575 and sentencing her to suffer the penalty of *reclusion perpetua* and to indemnify Perfect You Dermatological Laser Specialists, Inc. the amount of ₱801,051.75 is **AFFIRMED** with **MODIFICATION** that appellant is not eligible for parole. (*J. Brion, on leave; J. Perez, designated as Acting Member per S.O. No. 2067 dated June 22, 2015; J. Leonen, on leave under the Court's Wellness Program from June 16-30, 2015; J. Reyes, designated as Acting Member per S.O. No. 2056-C dated June 10, 2015*).
