

*Please take notice that the Court, Second Division, issued a Resolution dated 01 July 2015 which reads as follows:*

**G.R. No. 209784: PEOPLE OF THE PHILIPPINES v. DONARD DUMAPO**

After a careful review of the records of the case, the Court finds no reversible error in the assailed decision. However, when it imposed interest on all damages awarded, the Court of Appeals inadvertently failed to state in the dispositive portion that the interest rate will be paid “per annum.”

**WHEREFORE**, the Court **ADOPTS** the findings of fact and conclusions of law in the Decision dated 30 July 2013 of the Court of Appeals in CA-G.R. CR HC No. 00774-MIN, finding accused-appellant Donard Dumapo guilty beyond reasonable doubt of five counts of Rape under Articles 266-A and 266-B of the Revised Penal Code in Criminal Case Nos. 52,155-03 to 52,158-03 and 52, 160-03, and **AFFIRMS** said Decision with the **CLARIFICATION** that interest is imposed on all damages awarded at the rate of **6% per annum** from date of finality of judgment until fully paid.
