

*Please take notice that the Court, Second Division, issued a Resolution dated 21 January 2015 which reads as follows:*

**G.R. No. 213106: MERCEDITA DIMAL v. PEOPLE OF THE PHILIPPINES and CHARLIE SI**

After considering the allegations, issues, and arguments adduced in the Petition for Review on Certiorari<sup>1</sup> assailing the Resolution<sup>2</sup> dated January 29, 2014 and Resolution<sup>3</sup> dated June 18, 2014 of the Court of Appeals, Manila, in CA-G.R. SP No. 127477, we resolve to **AFFIRM** the assailed petitions for failure to show any reversible error.

We adopt the findings of fact and conclusions of law of the Court of Appeals.

However, consistent with this court's ruling in *Nacar v. Gallery Frames*,<sup>4</sup> if the adjudged amounts remain unpaid even after judgment becomes final and executory, the interest rate shall be 6% per annum computed from the finality of judgment until full payment of the award.

**WHEREFORE**, the assailed Resolutions are **AFFIRMED with MODIFICATION** in that the interest rate shall be 6% per annum on any outstanding balance on the adjudged amount computed from the finality of this decision until its full payment. (*Brion, J., on leave; Velasco, Jr., J., designated Acting Member per S.O. No. 1910 dated January 12, 2015.*)
