Sirs/Mesdames:

Please take notice that the Court, First Division, issued a Resolution dated April 20, 2015 which reads as follows:

"G.R. No. 214633 (James Pavon v. People of the Philippines).-The comment/opposition of private complainant/respondent to the petition for review on certiorari and the petitioner's compliance submitting the compact disc containing the soft copy of the motion for extension of time to file petition and a valid affidavit of service of the motion for extension of time to file a petition are both **NOTED**.

After a judicious perusal of the records, the Court resolves to **DENY** the instant petition and **AFFIRM** the May 7, 2014 Decision¹ of the Court of Appeals (CA) in CA-G.R. CR No. 35912 for failure to show that the CA committed any reversible error in upholding the conviction of James Pavon (petitioner) for violation of Batas Pambansa Blg. (BP) 22.²

As correctly ruled by the CA, petitioner clearly violated BP 22 when he knowingly issued worthless checks that were subsequently dishonored by the drawee bank. It is well-settled that the law seeks to address the pernicious practice of issuing a worthless check thus, the mere act of issuing a worthless check is in itself punishable under the law.³
