### NOTICE

Sirs/Mesdames:

Please take notice that the Court, First Division, issued a Resolution

dated June 29, 2015 which reads as follows:

"G.R. No. 218357 (P/Insp. Joel Fomokao, Philippine National Police [PNP], Daniel Pantaleon, Junofre Ballion, and Reynan Aprovechar v. Court of Appeals  $[21^{st}$  Division] and People of the Philippines). - After a judicious perusal of the records, the Court resolves to DISMISS the instant petition for *certiorari* under Rule 65 of the Rules of Court (Rules) for being the wrong mode of appeal to assail the August 13, 2014 Decision<sup>1</sup> of the Court of Appeals (CA) in CA-G.R. CR No. 00876-MIN, the proper remedy being a petition for review under Rule 45 of the Rules. The petition is evidently used as a substitute for the lost remedy of appeal.<sup>2</sup>

Records reveal that petitioners received the notice of denial of their motion for reconsideration on March 25, 2015,<sup>3</sup> hence, in accordance with Rule 45 of the Rules, petitioners had fifteen (15) days from its receipt, or until April 13, 2015 (April 9 and 10 being holidays and April 11 and 12 being Saturday and Sunday) within which to question their conviction. However, no appeal was taken within the said period, rendering the Decision of the CA final and unappealable.
