NOTICE

Sirs/Mesdames:

Please take notice that the Court, First Division, issued a Resolution dated October 9, 2019 which reads as follows:

"G.R. No. 248574 (Spouses Jose and Amelia Garcia v. Venus M. Lorea)

The petitioners' motion for an extension of thirty (30) days within which to file a petition for review on certiorari is **GRANTED**, counted from the expiration of the reglementary period.

After a judicious study of the case, the Court resolves to **DENY** the instant petition¹ and **AFFIRM** the April 5, 2019 Decision² and the July 24, 2019 Resolution³ of the Court of Appeals (CA) in CA-GR. CV No. 110184 for failure of petitioners Spouses Jose and Amelia Garcia (petitioners) to sufficiently show that the CA committed any reversible error in affirming the November 29, 2017 Decision⁴ of the Regional Trial Court of Manila, Branch 28 in Criminal Case No. 15-317472, finding them civilly liable to pay respondent Venus M. Lorea (respondent) the amount of \mathbb{P} 915,000.00, which shall earn an interest at the rate of six percent (6%) per annum from the date of judicial demand until the finality of this Resolution. Moreover, the foregoing amount shall further earn interest at the rate of 6% per annum from the date of finality of this Resolution until full payment.

As correctly ruled by the CA, respondent is entitled to receive actual damages as adequate compensation for such pecuniary loss which she may have suffered and had duly proved.⁵ While respondent

was only able to present an acknowledgment receipt evidencing payment of the initial P450,000.00, petitioners admitted during trial that they received a total of P915,000.00 from respondent as payment for the subject property.⁶ Settled is the rule that factual findings of trial courts, especially when affirmed by the appellate courts and supported by sufficient evidence, deserve respect and finality by this Court.⁷
