Please take notice that the Court, Second Division, issued a Resolution dated **24 August 2020** which reads as follows:

"G.R. No. 250133 (People of the Philippines v. Jaypee Diaz Francisco, Nelson Soriano Cajipe, and Noel Diaz Pacheco). — The Court NOTES the manifestation (in lieu of supplemental brief) dated June 29, 2020 of the Public Attorney's Office, adopting its brief filed before the Court of Appeals (CA) as supplemental brief, since the same had adequately discussed all the matters pertinent to the defense of accused-appellants Jaypee Diaz Francisco, Nelson Soriano Cajipe, and Noel Diaz Pacheco (accused-appellants).

After a judicious study of the case, the Court resolves to **DISMISS** the appeal¹ for failure to sufficiently show that CA committed any reversible error in the assailed Decision as to warrant the exercise of the Court's appellate jurisdiction.

WHEREFORE, the Court ADOPTS the findings of fact and conclusions of law in the May 30, 2019 Decision² of the CA in CA-G.R. CR HC No. 08974 and AFFIRMS with MODIFICATION said Decision finding accused-appellants GUILTY beyond reasonable doubt of the crime of Rape, defined and penalized under Article 266-A, in relation to Article 266-B of the Revised Penal Code. Accordingly, they are each sentenced to suffer the penalty of *reclusion perpetua*, and to each pay AAA³ the following amounts; (a) ₱75,000.00 as civil indemnity;
