Sirs/Mesdames:

Please take notice that the Court, Second Division, issued a Resolution dated 22 June 2020 which reads as follows:

"G.R. No. 244678 (People of the Philippines v. Jesmark Pajuelas y Heriales). – The records of this case were elevated to this Court on March 5, 2019, pursuant to the Court of Appeals Resolution¹ dated October 24, 2018 which gave due course to the notice of appeal filed by accused-appellant Jesmark Pajuelas y Heriales.

In compliance with the Court's Resolution dated April 1, 2019, both parties filed their respective manifestations, the Office of the Solicitor General's Manifestation dated June 25, 2019, stating that it sees no cogent reason to file a supplemental brief as it believes that it has already extensively discussed the relevant issues in the appellee's brief; and the accused-appellant's manifestation in lieu of supplemental brief dated July 1, 2019, adopting the appellant's brief as the same has adequately discussed all the matters pertinent to his defense.

After an exhaustive perusal of the records of the case, the Court resolves to **DISMISS** the appeal for failure of the accused-appellant to sufficiently show any reversible error in the challenged Decision to warrant the exercise of the Court's appellate jurisdiction.

WHEREFORE, the Court ADOPTS the findings of fact and conclusion of law in the Decision² dated September 14, 2018 of the Court of Appeals in CA-G.R. CR-H.C. No. 09054, finding accused-appellant Jesmark Pajuelas y Heriales guilty beyond reasonable doubt of Robbery with Homicide under Article 294(1) of the Revised Penal Code, as amended, and AFFIRMS said Decision *in toto*.
