**NOTICE**

Sirs/Mesdames:

*Please take notice that the Court, Second Division, issued a Resolution dated **11 November 2020** which reads as follows:*

**“G.R. No. 234787 (*Jaime C. Bonifacio v. Edelwina F. Asuncion and Osanna O. Asuncion*).** – After a judicious review of the records herein, the Court resolves to **DENY** the petition for review for failure to show that the Court of Appeals committed reversible error in its October 26, 2016 Decision<sup>1</sup> and October 10, 2017 Resolution,<sup>2</sup> in CA-G.R. SP No. 143360, dismissing the petition for *certiorari* filed before it.

It is settled doctrine that only questions of law may be entertained by this Court in a petition for review on *certiorari* under Rule 45 of the Rules of Court. In here, petitioner raises factual matters which the Court is precluded from entertaining. Although there are exceptions to the rule,<sup>3</sup> petitioner failed to present sufficient justification that his case falls under any of these exceptions.

**ACCORDINGLY**, the Court **DENIES** the petition; **AFFIRMS** the October 26, 2016 Decision and October 10, 2017 Resolution of the Court of Appeals in CA-G.R. SP No. 143360; and **ORDERS** petitioner **TO PAY** costs of suit.


