
*Please take notice that the Court, Second Division, issued a Resolution dated **05 October 2020** which reads as follows:*

“G.R. No. 236552 (*Omar Manonggiring y Diacat v. Office of the Ombudsman and SI Joselito C. Guillen, et al. of Anti-Organized Transnational Crime Division [AOTCD], National Bureau of Investigation [NBI], Taft Avenue, Manila*). – Considering the allegations, issues, and arguments presented in the Petition for *Certiorari*,<sup>1</sup> the Court resolves to **DISMISS** the petition for failure of the petitioner to sufficiently show that the Court of Appeals committed any grave abuse of discretion in rendering the assailed Decision<sup>2</sup> dated December 15, 2017, as to warrant the exercise of the Court’s appellate jurisdiction.

**WHEREFORE**, the Court **ADOPTS** the findings of fact and conclusions of law in the Decision dated December 15, 2017 of the Court of Appeals in CA-G.R. SP No. 151163, and **AFFIRMS** the Decision dismissing the complaint filed by petitioner against private respondents before the Office of the Ombudsman.
