
*Please take notice that the Court, Second Division, issued a Resolution dated **21 June 2021** which reads as follows:*

“**A.C. No. 10845 (Eye Center Conglomerate, Inc., represented by Dr. Raymond P. Evangelista v. Atty. Jay R. Villegas)**. – The Court **NOTES** the Notice of Resolution<sup>1</sup> dated June 18, 2019 of the Integrated Bar of the Philippines’ (IBP) Board of Governors which resolved to adopt the findings of fact and recommendation<sup>2</sup> of the Investigating Commissioner dated October 10, 2018 to dismiss the complaint, transmitted by the letter<sup>3</sup> dated March 12, 2020 of IBP Director Randall C. Tabayoyong, Commission on Bar Discipline, together with the records of the case.

The Court **RESOLVES** to **ADOPT** and **APPROVE** the findings of fact, conclusions of law, and recommendation of the Integrated Bar of the Philippines in the attached Report and Recommendation dated October 10, 2018.
