**Special Provision(s)**

1. Use and Allocation of Fund. The amount of One Billion Pesos (P1,000,000,000) appropriated herein for the School Building Program shall be used for the following: (i) construction, rehabilitation, replacement, completion and repair of kindergarten, elementary and secondary school buildings; (ii) construction of water and sanitation facilities; and (iii) acquisition of school desks, furniture and fixtures: PROVIDED, That the amount allocated by DepEd for school buildings shall be apportioned, as follows: (i) fifty percent (50%) to legislative districts, to be allocated pro-rata in accordance with each district's student population in relation to the total student population of the country; (ii) forty percent (40%) to legislative districts with classroom shortages as identified by the DepEd, to be allocated pro-rata in accordance with each district's classroom shortage in relation to the total classroom shortage of the country; and (iii) ten percent (10%) to be allocated in accordance with the policy considerations, as may be determined by the DepEd: PROVIDED, FURTHER, That all kindergarten, elementary and secondary school buildings to be constructed shall have its corresponding water and sanitation facilities.

The amount allocated by DepEd for the acquisition of school desks, furniture and fixtures shall be apportioned in accordance with Sections 4 and 5 of R.A. No. 7880 and its Implementing Rules and Regulations: PROVIDED, That the DepEd shall ensure that all school buildings to be constructed shall be provided with the corresponding number of school desks, furniture and fixtures.

Calamity stricken areas shall be given priority in the use of appropriations for the School Building Program.

2. Submission of Documentary Requirements. Within thirty (30) days from effectivity of this Act, the DepEd, shall submit to the DBM, either in printed form or by way of electronic document, the following: (i) program of work; (ii) list of the fifty percent (50%) of the school buildings to be funded per legislative district, including the water and sanitation facilities, indicating therein the number of classrooms per school, the cost of the project and the DPWH District Engineering Office where the funds will be released; (iii) details on the type, number and cost of school desks, furniture and fixtures corresponding to the school building to be constructed; and (iv) the request for Special Budget. The list of the remaining fifty percent (50%) of the school buildings shall be submitted to the DBM within six (6) months thereafter.

The DepEd shall likewise submit, either in printed form or by way of electronic document, to the House Committee on Appropriations and the Senate Committee on Finance copies of the list of school buildings to be funded from the School Building Program per legislative district, together with the work program, within the same period as above-stated. The Secretary of Education and the Agency's web administrator or his/her equivalent shall be responsible for ensuring that said list is also posted on the official website of the DepEd.

3. **Release of Funds.** The amount allocated for the construction, rehabilitation, replacement, completion and repair of kindergarten, elementary and secondary school buildings and the construction of water and sanitation facilities shall be released directly to, and administered by, the DPWH District Engineering Offices based on the list and program of work submitted by the DepEd to the DBM: PROVIDED, That in accordance with Special Provision No. 1 hereof and Section 4(b)(3) of R. A. No. 7880, ten percent (10%) of the appropriations for the School Building Program shall be released to the DepEd Central Office: PROVIDED, FURTHER, That the allocation for the ARMM shall be released directly to the Office of the Regional Governor.

LGUs or other organizations, with demonstrated capability to, and which will actually, implement the project by themselves, may also undertake the construction, rehabilitation, replacement, completion and repair of school buildings and the construction of water and sanitation facilities through the execution of a MOA with the DPWH for the purpose: PROVIDED, That said LGU or organization shall implement the projects in accordance with the specifications of school buildings and water and sanitation facilities prescribed by the DepEd: PROVIDED, FURTHER, That full payment to the LGU or the organization shall only be made after formal turnover to, and acceptance by, the DepEd of the school building and water and sanitation facilities constructed, rehabilitated, replaced, completed or repaired, as the case may be.

The initial release from this fund to the DPWH and DepEd shall be made within thirty (30) days after the receipt of the required documentations by the DBM as provided under the preceding special provision.

4. **Realignment of Projects under the School Building Program.** No realignment and relocation of school building projects already submitted to the DBM shall be made unless the same will result in the duplication and overlapping of funding source or an imbalanced allocation of projects: PROVIDED, That requests for realignment or relocation shall be supported by a certification from the Principal or Teacher-in-Charge that the said project has already been constructed or funded: PROVIDED, FURTHER, That such request for realignment may only be undertaken once per project and during the first quarter.

The Secretary of Education shall inform the DBM, in writing, of every realignment within five (5) calendar days from its approval and shall post the same on the official website of the DepEd.

5. **Inventory of School Buildings.** The DepEd shall submit, either in printed form or by way of electronic document, to the DBM, the House Committee on Basic Education and the Senate Committee on Education, separate annual reports indicating the total number of existing school buildings, as well as the number and cost of school buildings constructed in the current year, including the number of classrooms constructed for every school division funded by the National Government, LGUs, non-government organizations, and/or private individuals. The Secretary of Education and the Agency's web administrator or his/her equivalent shall be responsible for ensuring that said annual report is likewise posted on the official website of the DepEd.
